IT IS HEREBY RESOLVED ANE ENACTED by the Board of Supervisors of Lower Alsace Township, Berks County, Pennsylvania that a tax be and the same is hereby levied on all real property within the Township of Lower Alsace subject to taxation for the fiscal year 2017 as follows:

Tax rate for General Purposes, the sum of 7.25 mills on each dollar of assessed valuation, or the sum of .7250 cents on each hundred dollars of assessed valuation plus;

Local Services Tax - \$52.00 Per Capita - \$10.00 Fire Tax - .25 mills EMS Tax - .50 mills Antietam Lake Tax - .68 mills Real Estate Transfer Taxes – ½ of 1% Earned Income Tax – ½ of 1%

B. A motion to accept the 11/30/15 Treasurer's report and approve payment of the list of bills as presented was made by Supervisor Theodossiou, seconded by Supervisor Weikel, the motion carried.

C. Following a review of the proposed list of Township meetings for 2017, the board authorized the manager to advertise them according to the requirement of the Sunshine Act.
