Township of Lower Alsace, Berks County, PA September 8, 2016

The Lower Alsace Board of Supervisors met in regular session on Thursday, September 8, 2016 at 6:30 P.M. in the Township Municipal Building, 1200 Carsonia Avenue, Reading, PA.

I. <u>ATTENDANCE</u>

Board members present: James Oswald and Todd Weikel; John Theodossiou was not in attendance. Also in attendance was Homer Williams, Lower Alsace Township Resident, Berks County Commissioner Kevin Barnhardt, Lee Olson, Architect and President of Pagoda Foundation and Tom McMahon former Mayor for the City of Reading and Board member for Pagoda Foundation and Carol Duran from the Reading Eagle.

The meeting was called to order at 6:30 P.M. by the Chairman James Oswald and then followed with the pledge of allegiance to the flag.

II. VISITORS

Berks County Commissioner Kevin Barnhardt presented the Mt. Penn Preserve proposal which he described as the development of an organization of local citizens to help develop a Charrette Committee who will ultimately help to create a report with graphics delineating how the community at large sees the mountain being best utilized. The report will include an action plan and schedule and a potential organizational management. They attended the meeting with the hopes of seeking \$3,000; \$1,000 contributed by the County of Berks, \$1,000 from Lower Alsace and \$1,000 from Alsace Township to match a \$15,000 Peer to Peer Grant to complete a Master Plan.
