# Township of Lower Alsace, Berks County, PA December 20, 2018

The Lower Alsace Board of Supervisors met in regular session on Thursday, December 20, 2018 at 6:30 P.M. held in the Antietam High School Cafeteria, 100 Antietam Road, Reading, PA.

#### I. ATTENDANCE

Board members in attendance included Todd Weikel and John Theodossiou. Jim Oswald was physically absent but joined via phone.

There were more than 155 people in attendance who signed in. There were 142 residents, 13 non-residents that were registered. There were a total of 29 people who gave comment.

Solicitor Setley opened the meeting with rules of order and conduct in order for a public record to be kept and for all in attendance to be heard.

## II. TREASURER

A motion to approve the payment of the bills in the General Fund totaling to \$155,256.16 was made by Supervisor Theodossiou, seconded by Supervisor Weikel and all voted yes to approve.

### III. NEW BUSINESS

A. Supervisor John Theodossiou summarized a public handout of information as follows:

The Lower Alsace Township Board of Supervisors has received a price of \$227.00 per residential unit for weekly removal of up to six 35-gallon containers of trash, every other week removal of recycling, and monthly removal of bulk items. If approved, this service will only be available to residential properties with four or fewer units under a municipal hauling service. Properties with five or more residential units and all commercial properties will still be required to hire their own hauler but the must also recycle.

Beginning municipal, contracted hauling in Lower Alsace Township will also allow the township to be eligible for several new grant programs, including a potential recycling grant of over a quarter of a million dollars. This grant, if received, will allow the township to purchase additional equipment and enhance brush and leaf collection services for residents. With this program the township also expects to see a reduction of the number of large trucks causing added wear and tear on the neighborhood streets.

This price is a substantial reduction in costs for the great majority of the residents of the township. For that reason, along with the added benefit of recycling and bulk items removal, which is not offered by all of the private

haulers currently operating in the township, we believe it is in the interests of the residents of Lower Alsace Township for us to take the necessary steps to accept this price reduction and begin municipal hauling in April of 2019.
